FACILITY CIRCULAR NO.26/2020

Sub: Enbloc movement of containers from Port Terminals during the lockdown period of COVID-19 – Reg.

Attention of all importers, exporters, Customs Brokers, Custodians of CFSs, Port Terminal Operators, Shipping Lines/Shipping Agents, PGAs, members of the Trade and all persons concerned is invited to the above mentioned subject.

2. Due to the lockdown announced by the Government of India, it is noticed that many import containers could not be cleared from Port terminals which led to congestion of the Ports. In order to decongest the Ports and based on the requests from Port terminals, ICD & CFSs, it is decided to allow the terminals to move the DPDDPD, DPDCFS and PNR containers under enbloc movement to CFS or ICD mentioned in Annexure-A of this Circular.


3. As part of trade facilitation, it is also decided that all CFS/ICD are directed not to charge more than the below mentioned tariffs and strictly follow the conditions as mentioned below in the table:

S.No.	Free Storage Period for the containers at CFSs & ICDs	Transport & Handling Charges (For DPD & PNR under enbloc movement)
1	Lockdown Period + 5 Working Days	i. For 20' containers – not more than Rs.6,000/- ii. For 40' containers – not more than Rs.8,000/- iii. No additional charges shall be levied for handling the containers

4. Further, the CFSs or the ICD may charge lower rates than those indicated above based on contractual agreement with the importers or any other criteria.

5. The Port terminals are hereby instructed to inform the concerned importer/CHA about the details of the CFS or ICD to which container is moved. They should also ensure that the containers under the same IGM of the same importer shall not be moved to different CFSs or ICDs.

6. This is issued with the approval of the Commissioner of Customs, Chennai-IV.
