Attention of the Importers, Trade , Customs Brokers and all the stake holder is invited to clearance of **COVID-19 Rapid Diagnostic kit under heading Chapter heading 3822 from Guangzhou Wondfo Biotech, China and Zhuhai Livzon Diagnostics , China.** As per clarification F.No.29/Misc/31/2020-D dated 28.04.2020 issued by Drug Controller General (India) ( **Copy Enclosed**), the import licence holder of **COVID-19 Rapid Diagnostic kit** from these two sites have been asked to stop import of these kits in public interest and show cause notice has been issued for cancellation of import licence to various concerns under provisions of Drugs &Cosmetics Act,1940 and Rules .
